ELECTRONIC VOTING AT SHAREHOLDERS' MEETINGS



Introduction

The following is a Quick Guide for shareholders and proxies or representatives to use the Electronic Voting Service at Shareholders' Meetings as a support tool for the remote voting process.


OBJECTIVE

Provide instructions to Shareholders and Proxies on the efficient use of the platform and e-voting process.

PROCESS

Shareholder/ Traditional Proxy

1. All Shareholders / Proxies enrolled in the Electronic Voting Service will receive an email (according to the information provided in the Enrollment Request) containing the **control number or access Pin** to attend the Meeting and vote electronically. The system will be enabled 1 hour before the beginning of the event.
2. Shareholders / Proxies must log in to the platform through the access link provided in the email mentioned before and sign in to the corresponding Meeting with the provided **control number or access Pin** and Captcha. After entering the information in both fields, users will be directed to the main voting page.



3. Shareholders will log into the corresponding Meeting, and thus their attendance will be automatically registered. The following voting matters may be viewed by clicking on "Ver materias" (View Matters):



6. Next, click on "**Enviar Voto**" (Submit Vote) to register the vote on the platform. The following window will be displayed:




7. “**Seguir votando**” must be clicked if you wish to **continue voting**. This alternative will make the system available to vote on the following matter.



8. Next, click on "**Enviar Voto**" (Submit Vote) to register the vote on the platform.

Board Elections

1. Shareholders / Proxies will sign in to the corresponding Meeting; their attendance will be automatically registered, and the Directors' Election will be viewed.
2. To vote, Shareholders / Proxies must enter the number of shares selected in **the text box under the candidate's name (NOMBRE)**, and their votes may be distributed to one or more candidates.



FAQs

Is there a specific browser recommended?

Yes, Google Chrome.

What should I do if Internet connection is lost on my device?

If you are already logged into the Meeting, your participation will be registered automatically, even if you lose your Internet connection. Similarly, your vote will be registered in the Blockchain if you have already voted. Lastly, you may log into the Meeting again with the same credentials if you log out from the platform.

What can I do if I make a mistake when voting?

The platform allows you to change your vote until the voting for that proposal is closed. The voting process will be blocked to all participants from that moment on

What can I do if I cannot log in?

If the Meeting has not started and you cannot log in, the following is recommended:

- Check the access pin provided.
- Make sure you have entered the correct upper and lower case letters in the captcha.
- Update the captcha when logging in by clicking on the box in red (below).

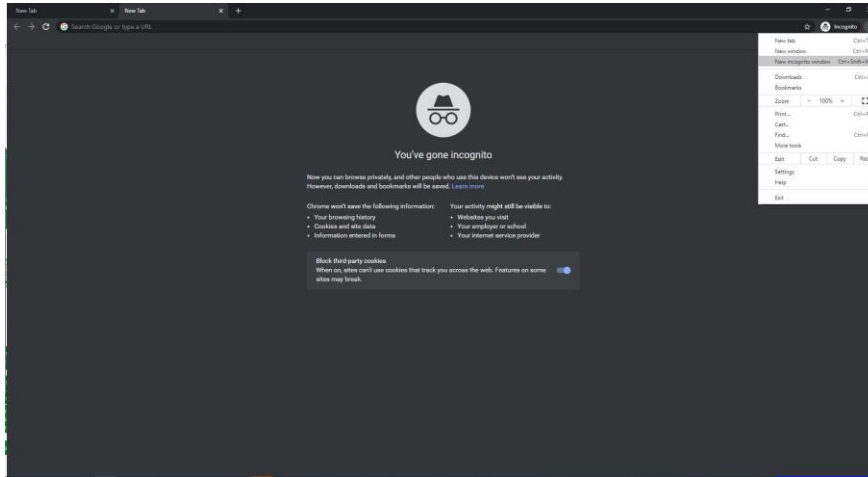

- Use the browser's private mode (open an incognito window) to log into the event. If using Chrome, in the upper right corner, click the three-dot icon, then select New Incognito Window. Afterwards, the event's URL must be entered in the address bar.



- Try to use another browser to enter the event's link.
- Try to log in through another device (computer, tablet, or smartphone.)

If the Meeting has started and the Issuer has decided to close the entrance to the Meeting, it will be blocked for new entries.

Finally, please get in touch with the Executive responsible for the event for more information if access problems continue.
